IDEA Annual Determination Letter Review

Mr. Peet explained that there were two areas that Sussex Academy were found to be non-compliant, which meant an improvement plan had to be created. We had two juniors that elected not to participate in the SAT testing (which there is no excusal), along with zero percent high school proficiency created by those two students, and the participation rate for ELA/Math created the non-compliance letter. A plan was submitted to the Department of Education.
